Technical and system administration conferences: At the Federated Conferences Week, (509 attendees), LISA (Large Installation System Administration) Conference (743 attendees), and Security (531 attendees), USENIX promoted the development, exchange and communication of research and technological information pertaining to operating systems, security, cloud computing, and system and network administration. Co-located workshops and exhibitions had 347 attendees. Grants allowed 127 students to attend the three major conferences. In addition to receiving travel stipends, the students were given free registration. Student authors submitting technical papers are eligible for best paper award.

4b (Code:) (Expenses \$ 869,920. including grants of \$) (Revenue \$)

Specific-topic conferences: At each of the USENIX single topic events - 4 in 2012, with 1316 attendees in total, the Association promoted the development, exchange and communication of research in more specific aspects of operating systems, networks, and programming. Subjects included file and storage technologies, operating system research and technologies, networked systems design and implementation, parallelism, provenance, security, and systems administration. 80 attendees participated in workshops attached to these events. Grants allowed 184 students to attend these special-topic conferences during the year. This support included travel stipends and free registration. Student authors submitting technical papers are eligible for best paper award.

Member benefits and publications: Magazine (;login:) published six times a year. USENIX keeps membership apprised of the latest developments in the field and reports on the conference events. A section of the USENIX web-site contains all the back issues as well. Proceedings and products: The proceedings of each conference are published, and they are available to members and non-members at no charge on the USENIX website after each conference and are available indefinitely. Video-recordings of most proceedings are also made available on the USENIX website.
