Event subjects included security, system administration; cloud and storage technologies; operating and network system design and implementation; and site reliability engineering.

Grants allowed 269 students to attend the these conferences by providing travel stipends and free registration. Student authors submitting technical papers are eligible for best paper award.

Form 990, Part III, Line 4d - Other Program Services Description

USENIX has two grant programs. The student grant program enables full-time students to attend USENIX conferences, workshops and symposia by assisting with travel, hotel and registration expenses. In the year 2014, awards were made to 269 students from many different institutions. Since 1990, this program has made over 3793 awards. The women's grant program supports travel expenses and/or event registration fees, and is designed to support equal representation for women in the field. In 2014, USENIX awarded 38 women's grants. Grant recipients are selected based on their involvement in the particular field and the strength of their application essay.

As part of its continued commitment to supporting education in advanced computing systems, USENIX provides funding for the USA Computing Olympiad, a computer problem

solving contest for high school students run by Dr. Brian Dean of Clemson University. Originally founded by Dr. Don Piele and developed with the assistance of Rob Kolstad, this group runs the US competition to select the USA team which competes at the International Olympiad in Informatics.

USENIX is an affiliate member of the Computing Research Association (CRA), and has sponsored some of its activities.

LISA Special Interest Group (SIG) is the USENIX special interest group for system administrators of information technology. Focused on education, LISA programs offer professional and technical information, tools, services and gathering places for the system administrator community.
